Terms and Conditions

Trade Promotion

1. Information on how to enter the Competition forms part of these terms and conditions of entry.
2. This Competition is being run at [BRANCH NAME] [ADDRESS] (the 'Store') during the Promotional Period and is only available to customers of the store.
3. This Competition commences at 9:00am Wednesday 1st March 2017 and concludes at 5.30pm Tuesday 11th April 2017 during the Stores usual trading hours ('Promotional Period').
4. The promoter of this Competition is Money3 Corporation Limited (ACL 389 782), (ACN 117 296 143) Level 1, 40 Graduate Road, Bundoora 3083. Telephone number 1300 329 131 ('Promoter').
5. Employees and immediate families of the employees of the Promoter and the associated companies are ineligible to enter.
6. Competition is open to all Australian residents above the age of 18 years ('Eligible Entrant').
7. One entry permitted per Eligible Entrant.
8. To enter the Competition, Eligible Entrant must:
 - a) apply for a new loan, by submitting a Money3 loan application at the Store during the Promotional Period;
 - b) complete an entry form; and
 - c) be successful in having the application approved ('Entry').

10. Money3 is required to meet its responsible lending obligations in relation to an application for credit.

12. An Entry that is incomplete, indecipherable, illegible or non-compliant with these terms and conditions is invalid and will not be accepted or considered.
13. The Competition draw consists of fifty (50) \$500 Money3 discount vouchers ('Prize') redeemable at participating stores against an approved Money3 loan. The total prize pool is \$25,000.

16. The winners' names will be published on Money3's website (www.money3.com.au) within two (2) business days of being determined/selected).

Failure to redeem the Prize within this time will result in it being forfeited and the Promoter may draw/select another winner for the Prizes, subject to any approval or directions of a relevant regulatory authority.

23. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If this Competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to modify, suspend, terminate or cancel the Competition to the full extent permitted by law and subject to any approval or directions from a regulatory authority.
25. The Promoter's decision is final and no other correspondence will be entered into.
26. It is a condition of entry that the entrant consents to the Promoter using the entrant's name, likeness, image and/or voice in the event they are a winner of a Prize (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of the Competition (including any outcome), and promoting any products and services, distributed and/or supplied by the Promoters or otherwise.

or indirect result of an entrant entering or participating in the Competition or winning or failing to win a prize, or using or permitting any other person to use the prize, except for any liability which cannot be excluded by law or which would cause any part of this clause to be void or unenforceable.

Privacy
